

## **Privacy statement Dietistenpraktijk DDietist**

Dietitian practice DDietist handles your personal details with care and confidentiality. This is recorded in the Personal Data Protection Act (WBP) and with effect from 25 May 2018 this is the General Data Protection Regulation (GDPR).

If you use the services of Dietistenpraktijk DDietist, we need information from you. You provide these by telephone (for example when making an appointment), via the contact with the dietitian, via the contact form on the website, via the intake form or via the mail. Think about:

- Name
- Date of birth
- Address data
- BSN
- Phone number / mobile number
- Health insurance details (name, policy number)
- E-mail address
- Certain, relevant, medical, lifestyle, measurement and private data

### **Why is that necessary?**

Dietitian practice DDietist needs your personal data to carry out her work in order to give you a personal dietary advice and then to provide it to you.

In some cases it concerns so-called 'special' and / or 'sensitive personal data' of you. We only do this if there is a need for this with regard to your treatment. Your personal data will not be used for commercial purposes.

### **How long do we keep your data?**

Dietitian practice DDietist stores your personal data 15 years after the end of the dietary treatment (obligation under the Medical Treatment Contracts Act).

### **Share with others**

Dietitian practice DDietist will provide your data to other care providers for treatment purposes if necessary and with your consent (eg reporting to the referrer or transfer to another institution on admission). Dietitian practice DDietist has agreements with other health care providers for safe data transfer.

Dietitian practice DDietist will only provide your data to an ICT hosting organization to store your data safely. With this organization Dietistenpraktijk DDietist has an agreement to ensure a standard level of security and confidentiality for this type of data. Dietitian practice DDietist remains responsible for this processing of your personal data.

### **View, modify and delete data**

You have the right to view your personal details, to have them corrected or to have them removed. You can send a request for access, correction or deletion to [info@ddietist.nl](mailto:info@ddietist.nl). An appointment will be made, because identification is always necessary to prove that it concerns your personal data.

### **Security**

Dietitian practice DDietist takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.
